UNIVERSITY REGULATIONS FOR ACADEMIC STUDIES

art.1) The University is committed to providing the student with the learning training necessary for their preparation both through the e-learning platform and through face-to-face teaching activities

art.2) The student is also given the opportunity to use other services that facilitate direct contact with the university through the establishment of learning centres located in the national, European and international territory. **art.3**) The academic year begins on 1 August and ends on 31 July, unless otherwise established by the academic authorities.

article 4) The student concerned may obtain enrolment in any month of the year and will be referred to the academic year to which the enrolment belongs. Enrolment is valid for all the years of the chosen course of study and is understood to refer to the entire course of study or rather to the completion of all the examinations of the course of study, including the final discussion of the thesis. The student will enrol in their chosen degree course and will have their enrolment automatically renewed from year to year until the completion of the course of study.

article 5) The amount of tuition fees and university contributions may be subject to possible increase according to the Istat index.

art.6) The student shall pay tuition fees and contributions in the amount determined by the University and published annually on its website, as well as the regional tax in the amount and in the manner established annually by DiSCo Lazio, for the purpose of validating the examinations. Enrolment is deemed to be executed upon completion of the application form, dated and signed, which constitutes a commitment to pay the amount due.

art. 7) Tuition fees shall be paid in 3 instalments: initial deposit of 10% to be made upon <u>validation of pre-</u><u>enrolment</u>; subsequent 60% within 15 days from the date of validation; remaining 30% due within 25 days from the date of validation.

By the end of the academic year, i.e. by 31 July, the student will be required to pay 20% of the entire tuition fee for the following academic year; by 15 September at the latest, the payment of the remaining 80% will be due.

In the event of non-payment or late payment of annual tuition fees, Unicusano University will notify the Embassy/Police Headquarters of the loss of student status, resulting in the loss of the visa/permit to stay for study purposes.

art.8) The withdrawal from studies, to be formalised online, shall have immediate effect only if the student is in good standing with the payment of tuition fees, contributions due and regional taxes relating to the academic years of enrolment.

The University will in any case place the student on "precautionary suspension of study cycle" until the administrative position is regularised.

For those who do not wish to be enrolled for the following academic year, the application for withdrawal must be submitted online by 31 July at the latest, by accessing the reserved area at https://sophia.unicusano.it. From the date of acceptance of the withdrawal, the student will cease all educational activity and all access to the platform and any administrative activity.

perform such tasks. Provision of personal data and retention period

Whether or not you provide us with your personal data, with the exception of those required by specific laws or regulations, remains optional. Your data may be kept beyond the strictly necessary period stipulated by legal obligations and in any case for the sole purpose of providing further guarantees to you as a student.

Rights of the data subject, restriction of processing, right to portability and right to lodge a complaint before the Italian Data Protection Authority (the so-called complaint under European Regulation 2016/679/EU)

Pursuant to the above-mentioned European Regulation, you have the right to be informed of the name, corporate or business name, domicile, residence or registered office of the data controller and data processor, the purposes and methods of the processing, as well as to promptly obtain from the data controller the following: a) confirmation as to whether or not personal data relating to you exist, regardless of their being already recorded, and communication in an intelligible form of such data and their source, as well as of the logic and the purposes underlying the processing. This request may be renewed, unless there are justified reasons for not doing so; b) cancellation, anonymization or blocking of any data processed in breach of the law, including data that don't need to be kept for the purposes for which the data were collected or subsequently processed c) updating, rectification or addition of data; d) certification to the effect that the operations as per Sections b) and c) have been notified, as also related to their contents, to the persons to whom or which the data were communicated or disseminated, unless this requirement proves to be impossible or would involve a manifestly disproportionate effort compared with the right that is to be protected. In addition to the rights listed above, within the limits of what is provided for in the new European Regulation, you may exercise your rights to restriction of processing, to object to processing and the right to portability exclusively for the personal data you have provided to the data controller in accordance with Article 20 of the aforementioned Regulation. We also inform you that according to the Privacy Code and the new European Regulation you can lodge a complaint to protect your rights before the "Garante Privacy" (the Italian Data Protection Authority), the so-called complaint pursuant to Article 77 of the aforementioned Regulation. Lastly, we inform you that, limited to certain data concerning you, you may exercise your right to withdraw your consent to the processing of your data by notifying the data controller of such withdrawal, provided that it does not affect the establishment and/or continuation of the relationship. This notice shall be signed in full by you and promptly returned.
