

#### DECREE N. 478/2022

#### THE RECTOR

**In relation to** art. 4 of Bill 03.07.98, n. 210 which requires Universities to regulate, with own Regulation, the establishment of PhD courses, the access and the title achievement, the education objectives and the related programme of studies, the duration, the fee for access and attendance, the award and the amount of the grant, the agreements with public and private bodies;

In relation to Ministerial Decree 30.04.99 n. 224, published on Gazzetta Ufficiale n. 162 of 13.07.99, with which the Ministerial Regulation on PhD courses has been issued, which determines the general criteria and the requirements for Universities to host the PhD courses, and which attributes to Universities the power to establish with Rectoral Decree the PhD courses provided eligibility is evaluated, to determine the education objectives and the related programmes of studies, to regulate the access, the duration, the grants and the fees for access and attendance;

In relation to art. 19 of Bill 240/2010 which issues new regulations about PhD courses;

**In relation to** Ministerial Decree 14.12.21 n. 226 which regulates the eligibility of venues and PhD courses and criteria for the establishment of PhD courses by eligible bodies

In relation to the new Regulation for the PhD courses issued with Rectoral Decree n. 382/2022 of 16.03.22;

**In relation to** Ministerial Decree of MUR of 06.08.21 by which favourable opinion is expressed for the activation of the PhD course in Management For Digital Transformation: Business, Communication and Ethics – XXXVII Cycle;

**In relation to** the application for the renewal of the PhD course in Management For Digital Transformation: Business, Communication and Ethics – XXXVIII Cycle, submitted to ANVUR and to MUR on 31.05.22;

**In relation to** the favourable opinion by ANVUR of 27.06.22 about the renewal of the PhD Course in Management For Digital Transformation: Business, Communication and Ethics – XXXVIII Cycle;

#### DECREES AS FOLLOWS

#### **ART. 1 – ACTIVATION OF THE PHD COURSE**

The XXXVIII Cycle for the PhD course in Management For Digital Transformation: Business, Communication and Ethics is activated at University Niccolò Cusano – Telematica – Roma. The PhD course has a three year duration.

## **ART. 2 – ADMISSION PROCEDURE**

The open call for admission, based on university curriculum and on exam, to the PhD course in Management For Digital Transformation: Business, Communication and Ethics for the academic year 2022/2023 – XXXVIII cycle – is announced, for a total of 5 positions, net of possible increments at Art. 9, of which:

- 1 position with grant funded by Niccolò Cusano University
- 2 positions with grant funded by Ministerial Decree 351/2022
- 1 positions with grant funded by Ministerial Decree 352/2022
- 1 position without grant.

The topics for research for the positions with grants funded by Ministerial Decrees 351/2022 and 352/2022 are in **ANNEX A**, which is integral part of the present call.



## **ART. 3 – ADMISSION REQUIREMENTS**

Applications to the PhD course are accepted from candidates, regardless of age and citizenship, who by **31 October 2022** hold an Italian laurea specialistica, laurea magistrale or vecchio ordinamento or any equivalent academic degree obtained abroad. In this latter case, if the title has not been declared as equivalent to one of the required Italian titles, the admission to this competition is subject to the ascertainment of the equivalence, for the sole purpose of the admission to the PhD course, by the Coordinator of the PhD course. For the sole position with grant funded by Ministerial Decree 352/2022 in collaboration with OPV Solutions S.r.l. applications are accepted from only candidates who by 31 October 2022 hold a laurea specialistica, laurea magistrale or vecchio ordinamento in mechanical or electronic engineering.

Candidates who will obtain their degree between the date of presentation of the application and 31 October 2022 are admitted with reserve; the winners must communicate to the Coordinator of the PhD course, under penalty of revocation, the obtainment of the title.

## ART. 4 - APPLICATION

The applications, to be written in plain paper exclusively according to the annexed scheme, must be submitted, **under penalty of exclusion**, only by Posta Elettronica Certificata (PEC) to the following PEC address: <u>dottorati@pec.unicusano.it</u>, by 1<sup>st</sup> September 2022.

The subject of the PEC message must be: "DOCUMENTAZIONE SELEZIONE AMMISSIONE DOTTORATO DI RICERCA IN TERRITORIO, INNOVAZIONE E SOSTENIBILITA' – XXXVIII CICLO".

If the deadline is a public holiday, the deadline is extended to the first useful working day.

The date of acquisition of applications is decided and proved by the correct receipt of the PEC message by the competent offices.

A copy of the identity document must be attached to the application.

The application, signed by the candidate and written in English (according to <u>ANNEX B</u>, only for citizens from European Community and from abroad) with clarity and precision under the responsibility of the candidate, under penalty of exclusion from the competition, must include the following declarations:

- a) surname (maiden name for married women), name, date and place of birth, residence address, citizenship and fiscal code;
- b) exact denomination of the call; specifying the curriculum: Innovation and Sustainability in Global Markets or Digital Communication and net-media It is allowed to apply for only one curriculum;
- c) to have an adequate knowledge of the Italian language or of the English language (for citizens from European Community or from abroad);
- d) exact denomination of the university title, with specification of the date of obtainment, final marks, university course duration, name of the University, or the equivalent title obtained in a foreign University, and the date of the decree by which the equivalence was declared by the competent ministry or by the Coordinator of the PhD course.

Candidates who obatined a university degree abroad not yet declared equivalent to one of the required Italian titles, must attach to the application the documents that are useful to issue the declaration of equivalence by the Board of Studies (Collegio dei Docenti).



These documents, under penalty of exclusion from the competition, must be translated and legalised by the competent Italian offices abroad, according to the regulations in force about the admission of foreign students to Italian university courses, and must be delivered by the application presentation deadline.

In particular, the student from countries other than the European Community must produce, under penalty of exclusion from the competition, if he is admitted to the PhD course, the declaration about the value of his title by two months from the approval of the competition proceedings;

- e) to commit herself/himself to attend the PhD course according to the rules that will be set by the Board of Studies (Collegio dei Docenti);
- f) to be/not to be an employee of the Public Administration;
- g) to have/not to have benefited from other grants for a PhD course (even for one year only);
- h) to have read the call for application;
- i) the address for the purpose of the competition, with specification of the postal code, telephone number, and email address with explicit statement of commitment to communicate promptly any variation of the address. Ideally as far as citizens from European Community and from other countries are concerned, an Italian address or the address of her/his Embassy in Italy, chosen as domicile.

The Administration can decide, with motivated rectoral decree at any stage of the competition procedure, the exclusion of the candidate for lack of requisites. The exclusion will be communicated by Posta Elettronica Certificata (PEC).

The Administration does not retain any responsibility for the missed receipt of the admission application that depends on the error of the candidate, or on possible mistakes due to actions of third parties, fortuitous event or force majeure.

Impaired candidates must specify in the participation application, according to the law in force, the support that is needed in relation to her/his impairment, and the possible need of additional time for the completion of the examinations.

Candidates whose applications do not include the following shall not be admitted to the competition:

- surname and name;
- residence address and address where the candidate intends to receive the communications related to the competition;
- the denomination of the PhD course;
- the exact denomination of the university title obtained, with the date of obtainment, the duration of the university course, the University, or the equivalent title obtained in a university abroad and the date of the decree by which the equivalence has been declared;
  - which position with grant the candidate applies for; choices are: position with grant funded by Ministerial Decree 351/2022, or position with grant funded by Ministerial Decree 352/2022 in collaboration with Al2Life srl e HEALTHIA srl. Candidates who apply for a position with grant funded by Ministerial Decree 352/2022 applies automatically for a position with grant funded by Ministerial Decree 351/2022.

#### ART. 5 – ADMISSION TESTS

The admission tests are aimed to evaluate the preparation of the candidate, her/his attitude to scientific research, and the knowledge of the English language.

The admission exam consist in the evaluation of titles, in the presentation of a research project, and in an oral test, according to the following:

a) EVALUATION OF TITLES (max 20 points).

Candidates must submit, as attachment to the admission application, the following documentation: Curriculum Vitae, possibly with qualifications and publications useful to the evaluation.

b) RESEARCH PROJECT (max 20 points).

Candidates must submit, as attachment to the admission application, the proposal of a research project in pdf format (max. 15.000 characters including spaces). The research project, written in Italian or in English, must include the following:

- o Title of the research and definition of the interest area;
- o Theory related to the thematic area;
- o Description of the specific investigation methodologies according to which the activities will be organised;
- o Project feasibility in the three year period and expected results;
- o Bibliographical references.

For candidates who apply for a position with grant funded by Ministerial Decree 351/2022, the research project needs to comply with the objectives of the National Recovery and Resilience Plan (Piano Nazionale di Ripresa e Resilienza, PNRR). The thematic area of the research project may be chosen among those listed in <u>ANNEX A</u>.

For candidates who apply for a position with grant funded by Ministerial Decree 352/2022, the thematic area needs mandatorily to be chosen among those listed in **ANNEX A**.

The research illustrated in the project proposal, and submitted in attachment to the application, is not necessarily the one that will be developed during the PhD. In case of admission, the research project that will be actually chosen will be later defined and approved by the Board of Studies (Collegio dei Docenti) of the PhD course, after the start of the PhD activities.

c) c) WRITTEN TEST (max 20 points).

The written test consists of a paper relating to the various subjects included in the curricula. Will be prepared n. 3 tracks, for each curriculum, and one of the three will be drawn. The candidate is required to necessarily carry out the curriculum theme indicated with the research project.

d) ORAL TEST (max 40 points).

The test consists in: discussion of the research project submitted; questions about the subject area; foreign language test.

For candidates from abroad, the oral test can be in a language different from Italian.

For <u>candidates who reside abroad</u> who have attached to the application explicit request, the oral test can be by teleconference using Skype, provided the identity of the candidate is ascertained. To this aim,



candidates must fill in the <u>form of request for the Skype videoconference</u> (**ANNEX C**), with attached double-sided colour copy of a valid identity document, with clear photo.

To access the oral test, candidate must have obtained a minimum of 40 points for the evaluation of qualifications research project and written test.

The written and oral test will be in the date and in the place indicated in the announcement posted in www.unicusano.it - section Concorsi/bandi-dottorato-di-ricerca. This announcement will be published from 10 September 2022 onwards and in any case at least 5 days ahead the test. This communication has full legal validity. Possible modifications will be announced on the same site.

#### **ART. 6 – EXAMINATION BOARD**

The Examination Board will be nominated by the Rector, after hearing the Board of Studies (Collegio dei Docenti). The Board will be composed by at least three Professors with specific expertise in the competition subjects.

The Examination Board can use at most 100 points for the evaluation of each candidate. In particular, the Board can use at most: 20 points for the evaluation of qualifications; 40 points for the evaluation of the research project; 40 points for the evaluation of the oral test.

Once the tests have been accomplished, the Board issues the ranking list on the basis of the sum of the points obtained by each candidate in the single tests and in the evaluation of qualifications.

The provisional ranking list, including those who have not yet obtained their degree, will be made public by the publication of the ranking list of the winners and of the eligible candidates on the university site: www.unicusano.it - section Concorsi/bandi-dottorato-di-ricerca.

The final ranking list will be made public in the same way after the rectoral decree of approval of the competition proceedings.

## ART. 7 - RANKING LIST

The final ranking list will be approved with rectoral decree.

In the eligibility ranking list candidates who have obtained at least 70 points are included.

In the case of ex-aequo among two or more candidates, the youngest candidate will be given priority.

Candidates will be declared winners according to the ranking list up to the positions set in the call.

Candidates in the useful positions of the ranking list must obey the dictates of Art. 8.

In the case of missed enrolment to the PhD course or waiver to go ahead in the course, which will need to be formalised by thirty days after the start of the course, other candidates will be admitted according to the ranking list.

#### **ART. 8 - ENROLLMENT APPLICATION**

Once the correctness of the competition acts is ascertained, the ranking list will be approved with rectoral decree and will be published in the official notice board of the University, and will be posted in the site http://www.unicusano.it – section Concorsi/bandi-dottorato-di-ricerca. Such publication will represent formal communication of the competition results to the winners.



The winners, by fifteen days after the start of the PhD course, must submit, **under penalty of revocation** – by Posta Elettronica Certificata to the address: <u>dottorati@pec.unicusano.it</u> the enrolment application <u>written with</u> <u>respect of the new legislation on the simultaneous enrolment for two high-level education courses pursuant Bill</u> <u>12.04.2022 n. 33</u> - this must include, in addition to personal data, the following declarations:

- a) That she/he has/has not already received a grant for a PhD course;
- b) That she/he is/is not a civil servant;
- c) That she/he commits herself/himself, in case she/he starts or already carries out external activities, to communicate this to the University Administration, in order for the Board of Studies (Collegio dei Docenti) to decide whether the attendance of the PhD course and the above mentioned activities, which need not be in conflict with PhD activity, are compatible;
- d) In the case she/he receives the grant, that she/he will not cumulate the grant with any other grant except for the grants granted by national or foreign institutions aimed to integrate, with periods spent abroad, the PhD research activity.

and the following self-certifications pursuant to Italian Presidential Decree 445/2000:

- citizenship;
- university title;
- personal expected income for the year 2022 (year of possible payment of the grant).

Candidates must, in addition, submit together with the enrolment application, under penalty of revocation, the following documents:

- copy of the identity document, duly signed;
- copy of fiscal code;
- 2 recent photos of equal size (cm 4 x 4,5), signed on the back;
- receipt of the payment of the regional tax for the academic year 2022-2023;
- receipt of the payment of the first instalment of the contribution for the access and attendance of the PhD course, equal to € 1.500,00 by bank transfer for the benefit of Università degli Studi "Niccolò Cusano" - Telematica Roma, CHEBANCA! IBAN IT67M0305801604100573023915, notwithstanding the exemption for those who will benefit from the grant.

Those who will not have settled their enrolment by the above mentioned terms, will be declared deprived; those who will have released false declarations will be declared deprived and the positions made free will be assigned to other candidates who follow in the ranking list.

The University Administration bears no responsibility for dispersed communications, dependent on incorrect domicile or late information about changes of domicile or possible postal/telematic problems not imputable to the University Administration.

## ART. 9 - GRANTS

The number of grants normally assigned can be increased according to funding from public and private bodies, after the publication of the present call. The increase will be formalised with rectoral decree.

Grants are defined as additional if additional funding comes from public or private bodies after the publication of the call. If such funding is granted before the admission tests, the additional grants can be approved and the positions increased. If, on the contrary, funding is granted after the admission test, only the number of grants will be increased. The increase of grants and positions will be made public exclusively by announcement on the university site <u>http://www.unicusano.it</u>.



Grants, of an annual amount of € **16.243,00** (subject to pension scheme contribution of INPS gestione separata), pursuant to Ministerial Decree 23.02.22 n. 247 are assigned according to the comparative evaluation and to the ranking list formulated by the Examination Board.

The duration of the grant covers the entire duration of the PhD course.

Those who already benefited from a grant for a PhD course, cannot benefit from a grant a second time.

The grants cannot be cumulated with any other grant except for the grants granted by national or foreign institutions aimed to integrate with periods spent abroad the research activity of the PhD student.

The amount of the grant, can be increased for periods spent abroad up to 50%. These periods shall not be longer than half the entire duration of the PhD course.

The payment of the grant is by postponed monthly instalments, on the basis of certification released by the Coordinator of the PhD course at the start of the course and every three months.

If one instalment is not paid because of delay in the start of the course or for delayed submission of the attendance certification, this will be cumulated with the subsequent instalments.

To benefit from the grant, gross income cannot be higher than € 16.000,00.

Those who can benefit from the grant must submit together with the enrolment a declaration about the expected gross income and the about the absence of the incompatibility conditions listed in the present paragraph. This declaration must be repeated at the start of every year of attendance. The forms to be filled in will be available from the University Administration.

## **ART. 10 – CONTRIBUTION FOR ACCESS AND ATTENDANCE**

The contribution due to the access and attendance of the PhD course, which must be paid by those who do not benefit from the grant, is Euro 3.000,00 every year, divided as follows:

- 1st instalment: Euro 1500,00 on the occasion of the enrolment to the 1st year
- 2nd instalment: Euro 1500,00 by sixty days after the enrolment, for the 1st year
- 1st instalment: Euro 1500,00 by 1 November 2023 for the 2nd year
- 2nd instalment: Euro 1500,00 by 31 December 2023 for the 2nd year
- 1st instalment: Euro 1500,00 by 1 November 2024 for the 3rd year
- 2nd instalment: Euro 1500,00 by 31 December 2024 for the 3rd year.

#### ART. 11 – OBLIGATIONS OF THE PHD STUDENTS

PhD students are obliged to follow the study programme decided by the Board of Studies (Collegio dei Docenti).

Pursuant to art. 12 of Ministerial Decree 226 of 14 December 2021, the admission to the PhD course implies an exclusive and full-time commitment.

In particular, the research activity is key and, pursuant art. 12 of Ministerial Decree 45/2013, PhD students will carry out tutoring activities for four hours a day five days a week.

For grants funded by Ministerial Decree 351/2022, the acceptance of the grant implies the obligation to spend a period of study and research outside Italy of duration from a minimum of six (6) months to a maximum of eighteen (18) months.

For grants funded by Ministerial Decree 352/2022, the acceptance of the grant implies the obligation to spend a period of study and research in the firm of duration from a minimum of six (6) months to a maximum of eighteen



(18) months, and a period of study and research outside Italy of duration from a minimum of six (6) months to a maximum of eighteen (18) months.

Compatible activities are permitted, provided these are authorised by the Board of Studies (Collegio dei Docenti). These external activities cannot be in conflict with the activity carried out by the PhD student.

Possible delays in the date of start or interruptions will be proposed by the Board of Studies (Collegio dei Docenti) and authorised with subsequent rectoral decree for the benefit of the PhD students who can demonstrate to be in the conditions stated in the Bill 30.12.1971, n. 1204 and subsequent modifications and integrations, or who are in serious and prolonged illness conditions.

In the case of insufficient results, the Board of Studies (Collegio dei Docenti) will propose to the rector the emanation of a provision of exclusion of the PhD student. In this case, the PhD student is obliged to pay back the entire amount of the grant for the given year, or the instalments paid.

## ART. 12 – PhD TITLE

The PhD Title is awarded by the rector after the conclusion of the course and is obtained in the occasion of the final examination, which can be repeated only once.

The examination boards for the final exam will be formed and nominated with rectoral decree.

## ART. 13 - INSURANCE

The University protects the PhD students, during the teaching activities, against the risk deriving from the civil responsibility towards third parties.

PhD students must pay the fees for a risk of accidents insurance in case they decide to protect themselves against that risk.

## **ART. 14 – APPLICABLE REGULATIONS**

For all matters that are not expressly disciplined by this call, please refer to the specific rules governing the PhD area and the "Regolamento di Ateneo in materia di dottorato di ricerca".

## ART. 15 - RESPONSIBLE OF THE PROCEDURE

Ms Valentina Di Pietrantonio is the responsible for every accomplishment related to the present call that is not of competence of the Examination Board.

## ART. 16 – TREATMENT OF PERSONAL DATA

The university administration in relation to Legislative Decree n. 196 of 30.06.03 and subsequent modifications and integrations and to the EU Regulation 2016/679 providing dispositions on the protection of persons and other subjects, commits itself to use personal data provided by the candidate only for institutional purposes and for the execution of the competition procedures.
